100% Health (« 100 % Santé »)

French healthcare cover is set to undergo a raft of new changes and they are called "100% Health" (100% Santé). The reform is designed to help cover without co-payment

- Eyecare appliances
- Dentures
- Hearing aids



For each set of guarantees, the objective is to carve out a basket of services, sold at controlled pricing, and that will be covered a 100% by social security and supplementary health coverage plans

O Eyecare

Basket of complete "zero co-pay" appliance, 2 lenses plus frame (€ 30 max), with a maximum price between €95 and €370 to be covered at 100%.



Hearing aids

Basket of appliance with complete "zero co-pay" by 2021



Dentures

Set up of a 3-level co pay systembased on tooth location and crown material. Level I targets no co-pay.

Key features – dental



Average co-pay falling on households for denture work amounts to 40 %.

There will be three milestone dates for the introduction of "zero co-pay".

- I April 2019 will see the application of initial capping of prices for crowns.
- "Zero co-pay" will then come into effect from I January 2020 for crowns and bridges, with new price caps.
- In the end, removable resin dentures will come into the "100% healthcare" basket as from 1 January 2021.



Key features – Hearing aids



Average co-pay falling on households for hearings aids amounts to 57 %.

Zero co-pay" will come into effect from 2021 as a result of a drastic cut in pricing and a significant increase in the cover provided by first and second tier health insurers.

Between now and 2021, the amount remaining for the patient's account will be cut to zero in three stages: co-pay will be reduced to €1,300 (for the two ears) in 2019 and then to €800 in 2020 and finally to 0 in 2021. This benefit will be restricted to a "100% healthcare" basket comprising a number of types of device capable of providing at least 30 decibels of amplified sound output and 12 adjustment channels



Key features – eyecare



For a complete "zero co-pay" appliance, 2 lenses plus frame, the maximum price will be between €95 and €370. People will be able to benefit from this scheme once every two years, just as today.

Complementary healthcare insurance schemes will have to offer the "100% healthcare" basket with the new controlled prices as part of responsible policy cover. Also, the upper limit on responsible policies could well be slightly reduced with the maximum cover for refunding frames will come down from €150 to €100.

The start date for the "100% healthcare" basket for optical treatments is set for I January 2020
